

Three (3) members of the Standing Committee shall constitute a quorum at any meeting of the Committee for the transaction of ordinary business, but no appropriation of money shall be made unless five (5) members be present. Section 3. Special meetings of the Standing Committee may be called at any time by direction of the President, or shall be called upon the request in writing of three (3) members thereof, of which at least ten (10) days notice shall be given by the Secretary. Article V. Nominating Committee. Section 1. A committee of three (3) members shall be balloted for and elected at the Annual Stated Meeting on May 10th, to serve for the ensuing year, whose duty it shall be, upon the call of its Chairman, to convene and nominate a ticket for the respective offices of the Society, including the Officers, Chaplain, Assistant to the Secretary, Standing Committee, Delegates and Alternates to the General Society, member of the Standing Executive Committee of the General Society, member of General Society Committee on Nominations of General Officers, and Trustees, to be balloted for at the next annual meeting of the Society on July 4th. Section 2. The Nominating Committee elected at the Special Meeting of...
