

My written testimony touches upon several provisions in the tax code that create some distinctions between small and large busi-nesses. Some of those differences are favorable to small businesses. Some are unfavorable. The point I want to emphasize is the inordi-nate compliance cost placed on small businesses today. IRS data indicate that there are both significant amounts of under reporting of income by small businesses and significant com-pliance costs placed on small businesses, and there may be a cor-relation between the two. While noncompliance is not to be con-doned, it can be understandable how the heavy compliance burdens may generate the result of noncompliance with some of the rules of the tax system. Examining compliance costs, one IRS study found that busi-nesses with less than 10, 000 in annual receipts faced compliance costs that were twice as large as the total receipts of the business. Even as you expand to slightly larger small businesses, for exam-ple, those businesses with receipts between 100, 000 and 500, 000, compliance costs are estimated to be about five percent of total re-ceipts. Again, that is measured relative to receipts, not income. Income for such firms on average is about seven and a half per-cent of total receipts. As a result, compliance costs for these busi-nesses represent an additional...
